Dear Commandant Chapman:

The Accrediting Commission for Community and Junior Colleges, Western Association of Schools and Colleges, at its meeting January 7-9, 2015, reviewed the Follow-Up Report submitted by Defense Language Institute Foreign Language Center. The Follow-Up Report was certified by college leadership, including the chair of the Board of Visitors, the college commandant and provost, and leaders of the faculty organization.

Based on the College Report and evidence submitted, the Commission finds that the College has addressed Recommendations 1, 2, 3, 4, 5, and 6, and has fully resolved the deficiencies in College policies, procedures, and practices which led to noncompliance with Standards I.A, I.B.5, I.B.6, II.A.2, II.B.2, II.B.3.a, II.B.3.e, II.C.1.c, IV.A, IV.A.2, IV.A.5, IV.B, Eligibility Requirement 3, and the Policy on Governing Boards for Military Institutions.

The next report required from the College will be the Midterm Report in spring 2015. Institutions are expected to meet Eligibility Requirements, Accreditation Standards, and Commission policies at all times during the six-year review cycle. Defense Language Institute Foreign Language Center must demonstrate to the Commission at the time of the Midterm Report that the recent changes implemented to resolve deficiencies and meet Eligibility Requirements and Standards have been sustained. The College should submit the **Midterm Report** by **March 15, 2015**.<sup>1</sup>

The Follow-Up Report submitted in October 2014 will become part of the accreditation history of the College. The Commission requires that you give the Follow-Up Report and this letter appropriate dissemination to your College staff and to those who were signatories of the Report. This group should include the campus leadership, and the Board of Visitors.

The Commission also requires that the Follow-Up Report and this Commission action letter be made available to students and the public by placing a copy on the College website. *Please note that in response to public interest in disclosure, the Commission now requires institutions to*
